6. NORTH LODGE PARK COMMITTEE

- **Co-option of Friends Representatives:-** It was **AGREED** to co-opt Carolyn Candish, Emma Dale, Barry Meadows, Carol Ormrod, Rosemary Price and Sylvia Kilshaw onto the North Lodge Park Committee. The representatives will be invited to join the meeting to be held on Thursday 8th January, 2015 and sign the necessary legal paperwork.
- **6.2 CCTV:-** The Clerk reported that North Norfolk District Council do not have a report on the condition of the CCTV camera they have left in North Lodge Park and this will need to be investigated. It was **AGREED** that this item will be placed on the next agenda for further discussion.
- **Committee Budget 2015/16:-** It was **AGREED** that the Committee Budget be accepted in the sum of £168,626 expenditure and £150,000 income.

7.1 Emma Dale reported that at their last meeting the Friends formed a wider group and a Committee of six representatives who will be co-opted onto the North Lodge Park Committee. The Constitution is being agreed and there is a lot of support for Cromer Town Council taking on North Lodge Park.

- **8.3** The Clerk read a letter received from a member of the public with suggestions for the use of North Lodge Park which was noted.
