A residential reduction will apply to all fees, payments and sums set out below where the deceased person is an inhabitant of the Parish of Cromer. For the purpose of determining fees, an inhabitant of Cromer is a person who is listed on the current Register of Electors. Former inhabitants who, at the time of death, were resident in a retirement home outside of Cromer will be treated as inhabitants if they were a long term resident of Cromer prior to moving into residential care.
