4. RESPONSE TO CONSULTATIONS

NCC Local Transport Plan:- Cllr. Harris circulated the proposed response from Cromer Town Council which was **AGREED**. It was **AGREED** that the Clerk would send the response to Norfolk County Council with a comment that Cromer Town Council is disappointed that we had no official request to respond to this consultation. Cllr. Harris will liaise with Norfolk ALC to discuss Cromer Town Council's response and the comments that have been made about the faults with the SatNav technology which results in large lorries driving through the centre of town. It was **AGREED** that a copy of our response will be sent to North Norfolk District Council.

Norfolk Rail Prospectus:- Cllr. Harris circulated the proposed response from Cromer Town Council which was **AGREED**. It was reported that this consultation only takes place every ten years. It was **AGREED** that the Clerk would contact Sheringham Town Council to ask for their support and send them a copy of our response.

Greater Norwich Local Plan:- Cllr. Harris reported that we are unable to respond to this consultation as the plan does not cover Cromer. It was **AGREED** that the Clerk would write to Norfolk County Council and express our disappointment with the fact that Cromer and other areas of North Norfolk have not been included. Cllr. Harris will discuss this matter with Norfolk ALC. Cllr. Harris will thank John Pennell on our behalf for his work on this matter. The Members thanked Cllr. Harris for his hard work on the responses to the consultations.
